Bones Muscle Power

If we had a Facebook survey asking “Why did you purchase a Rottweiler? “Why this breed over others?” it would elicit interesting answers. I cannot say what the attraction others have for the Rottweiler, but for me, it was his raw masculine appeal, unique head, impressive musculature and the power he conveys. From his appearance, I could see the Rottweiler is a serious dog. Not alone in this view, many other Rottweiler aficionados recognize the hallmarks of the breed. Is not the “look” of a dog that makes the first and lasting impression?

WHAT ARE CORRECT BONES AND MUSCLES?

Two traits that attract us to the Rottweiler are his bone mass and musculature. What is correct for bones and muscle mass? Should the muscles bulge from the bones? Should they be refined and blend in? Confusion and doubt abound. How do we establish what is proper?

We must refer to the blueprint. From the standard: **His correctly proportioned, compact and powerful build leads to the conclusion of great strength, agility, and endurance.** It gives no numerical values to guide us, only a semantic direction. Therefore, to state a formula, “Dog X must have Y amount of bone and muscle to be correct is not possible.

But an alternative method for assessing whether a Rottweiler is correct or incorrect for his bone mass and musculature is to ask three simple questions, “Does the dog exemplify a powerful appearance?” and “Is the bone and muscle mass in balance to the dog’s size? If not, why not? An explanation of muscle and bone mass is necessary.



MUSCLE MASS



The general muscle mass should be well-defined and in proportion to the frame of the dog, so it exudes strength, masculinity, and athleticism. The muscles should be apparent, yet not overpowering, like the Bull and Pit Bull Terriers. The muscle groups that comprise this “appearance” are the muscles of the front and rear assembly.

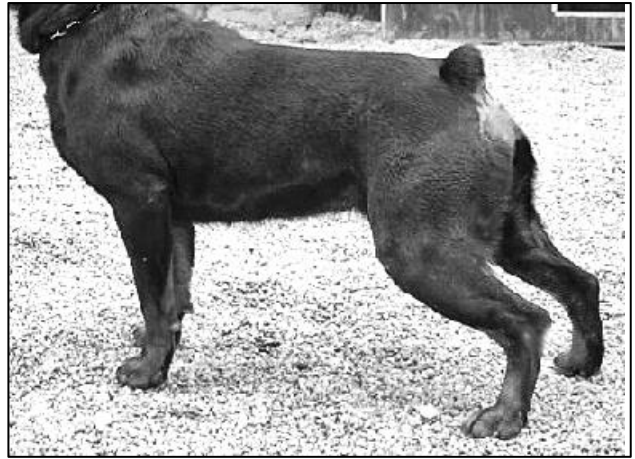
In the front assembly, the muscles of the shoulders, the upper arm and forearm should be well developed and distinct. These muscle groups are:

- Deltoids
- Biceps
- Triceps
- Extensor muscles of the radius/ulna.

In the rear assembly, the muscles of the Gluteus and Biceps Femoris should be well developed and defined. Viewing the rear muscles, the depth, and width of the

- Biceps Femoris
- Gluteus

Should be substantial to support the Femur. These drive forward locomotion. The Biceps Femoris of the bitch is often more pronounced than the dog's rear muscles.



CORRELATION OF MUSCLE AND BONE

With human body-building, the muscles can be developed, shaped and improved, with discipline, hard work, good nutrition and much sweat. However, improvement has limits; body-building depends on the size, the mass of the muscle groups and bone substance, you are what you inherited. The thin-framed, fine-boned man or woman will work harder and longer to build bulk and definition in the muscle tissue. In those body types, the significant limiting factor is bone mass. Thick muscles support strong bones. Thin muscles support fine bones. The same principle applies to the Rottweiler.

Fine boned dogs and bitches possess muscles, which are light in their mass and often show little or no definition. This type will always work harder to make strides improving and developing what it inherited from the pedigree. Conversely, there are dogs and bitches, which impress us with their natural well-developed musculature and great bone mass. Their musculature is correlated to their robust bone mass.

BREED TYPE IS PRIORITY

At ringside, we often hear spectators, owners, handlers, and breeders say, "Oh that dog moved beautifully with great reach and drive," "It was well put together." Yes, that could be said, however, the dog looked more like a Doberman than a Rottweiler. Sound structure, under the breed standard, is essential. But superior construction and gait are not type. They are secondary traits in a breeding program and not interchangeable with it. They must be layered in like building blocks with type as the foundation. Be cognizant of bone and muscle mass when selecting breeding partners and puppy selection.

Jan also used to help out at the Dogs Breath Café at the Royal Show and did so for many years.

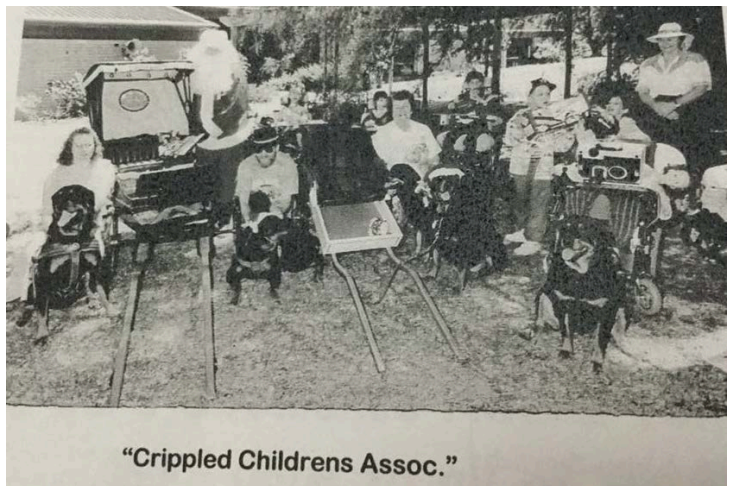

Current Wording in the "Application to hold a National" document, point 37 that

CURRENTLY IS:

37. 'V' (Excellent) medallions are to be presented (on the day) to all dogs/bitches that achieve scores of 96% or greater, e.g. 96 or higher out of 100, 192 or higher out of 200 and 288 or higher out of 300.

PROPOSED TO BE REPLACED WITH:

37. 'V' (Excellent) medallions presented at a National Obedience and Rally Obedience trial (on the day) be given to all dogs/bitches that achieve scores of 90% or greater, i.e. a score of 190 or higher out of 200 for Obedience; and a score of 90 or higher out of 100 for Rally Obedience; and that "V" medallions be presented to all dogs/bitches that achieve a score of 85 or higher out of 100 for National herding trials.

Proposed RCVIC

Rationale

For Obedience and Rally Obedience no other breed club requires a score above 90% to achieve an Excellent rating at their National competitions.

For Herding a score of 85 was agreed to at a recent Herding Association meeting when determining what was required to obtain a Champion title, which is 5 passes at Advance level with scores greater than 85.

PROPOSED MOTIONS FOR CLUB VOTING

MOTION 1

Amendment to the current Rottweiler Litter Registration Limitation with ANKC re: HD requirements – introducing cut off scores.

Current ANKC requirement: That for litters of Rottweilers born where the parents have been born after 1.1.97, these parents must show official radiology scoring results of X-rays for hips and elbows.

Add (replace): For all Rottweiler litters born from 1 January 2019:

Each parent of every litter must be screened for Hip Dysplasia through an official Hip Dysplasia Control Scheme. Where the parents have been born after 1 January 2017, they must record a score of no more than 25 (TOTAL left and right hip) or, in the case of imported animals, a grading that is deemed to be acceptable for breeding in their country of origin.

Litters born after 1 January 2019, will be required to comply as a prerequisite to registration of any litter on the ANKC Main Register.

Dogs must be positively identified by microchip, or tattoo prior to being x-rayed, noting that results for hips are not accepted for dogs screened under 12 months of age. Litters which do not meet the above requirements will be placed on the Limited Register and will be flagged “NOT TO BE UPGRADED”.

Rationale: LRL's (Litter Registration Limitations) have been in place since 1997 and as the breed average is now well under 8 (as at August 2017), it is felt that the next appropriate move is to limit the breeding of high scored animals in the area of hip dysplasia.

Since 1996 it has been mandatory for members of National Rottweiler Council of Australia - NRC(A) and for all members of Australian (State) Rottweiler Clubs to have their dogs x-rayed through an official Hip Dysplasia Control Scheme. For litters where the parents have been born after 1 January 1997, this was a prerequisite to register any litter with the ANKC. Large quantities of data has been collated over this time from certified and recognised HD readers and the NRC(A), AVA (Australian Veterinary Association) AND various OTHER Australian HD REGISTERS.

PROPOSED MOTIONS FOR CLUB VOTING

MOTION 2

Amendment to the current Rottweiler Litter Registration Limitation with ANKC re: ED requirements – introducing cut off scores.

Current ANKC requirement: That for litters of Rottweilers born where the parents have been born after 1.1.97, these parents must show results of X-rays for hips and elbows.

Add (replace): For all Rottweiler litters born from 1 December 2018:

Both parents of every litter must be screened for Elbow Dysplasia through an official Elbow Dysplasia Control Scheme. Where the parents have been born after the 1 July 2017, they must record an ELBOW grading of: Normal, Grade 1 or Grade 2 on both elbows up to a maximum of 5mm. Grade 2 elbows with greater than 5mm and Grade 3 elbows should not be bred from.

Litters born after 1 January 2019, will be required to comply as a prerequisite to registration of any litter on the ANKC Main Register. Dogs must be positively identified by microchip, or tattoo prior to being x-rayed, noting that results for elbows are not accepted on dogs under 12 months of age.

Litters which do not meet the above requirements will be placed on the Limited Register and will be flagged “NOT TO BE UPGRADED”.

Rationale: LRL's (Litter Registration Limitations) have been in place since 1997 and it is felt that the next appropriate move is to limit the breeding of high scored animals in the area of elbow dysplasia.

Since 1996 it has been mandatory for members of National Rottweiler Council of Australia - NRC(A) and for all members of Australian (State) Rottweiler Clubs to have their dogs x-rayed through an official Elbow Dysplasia Control Scheme. For litters where the parents have been born after 1 January 1997, this was a prerequisite to register any litter with the ANKC. Large quantities of data have been collated over this time from certified and recognised ED readers and the NRC(A), AVA (Australian Veterinary Association) AND various OTHER Australian ED REGISTERS.

PAGE 2 MOTIONS

The following Motions have been voted on by the members of the Northern Districts Rottweiler Club:

1 That the NRCA president can not be a president or on the committee of any other club

Rationale: That it is a conflict of interest

1. NOTE: Unfortunately this motion will need to be amended and redistributed for consideration and cannot proceed as a Motion on Notice.

Suggestion wording : The President of the NRCA shall not hold the Position of PRESIDENT of a STATE ROTTWEILER CLUB at the concurrent time of His/her tenure due to potential conflicts of interest. (The motion as presented by NDRC is not workable in its current form due to the potential situation that a NRCA President may hold a position on, for instance, an obedience, agility, herding or a different breed clubs committee or executive position and therefore is too restrictive and not in anyone's interest to hinder participation or holding a committee position or office position in any other club/s). This item has been moved to 2018 SGM to be discussed in General Business.

2. Re NBC Press release-ANKC notice re National Breed Councils meeting

- NRCA president and Secretary who attend this meeting. That they should get the ANKC to come inline with our NRCA scheme for hips and elbows and eye and mouth certificates

Rationale: We have invested a lot of time and effort over the years to improve all scores with outstanding results for the breed. To have conformity across NRCA and ANKC for these scheme is greatly advantageous to the breed and the administration of both ANKC and NRCA. So that all Rottweiler breeders fall under the NRCA guideline regardless if they are members of a club or not so they are accountable for what they are breeding to improve the betterment of the breed

2. NOTE: fortunately this motion cannot proceed due to the incorrect wording, intention and ANKC requirements of LRL. (Limited Register Limitations-LRL's)

Re the wording. Although the intentions of the motion have merit, we simply cannot "get the ANKC to come inline..."

The correct avenue for this intention is to move a motion of intent for LRL as per the ANKC National Breed Councils process (a proposed motion is prepared and will be moved to the 2018 SGM agenda to be discussed in General Business.

3. JLPP and compulsory testing before registration

NDRC proposes all puppies be JLPP tested prior to registration

Rationale: This ensures all litters will be tested with no puppies breed carrier to carrier. Raising the bar for the breed as healthy and one that the general population, breeders and Rottweiler lovers can have confidence in

3. Note: Unfortunately this motion cannot proceed in this format. It needs to be put as a motion to request the ANKC as per a LRL as per the Motion 2 above requirements (request for LRL). Also noted is the intent of this proposal for all PUPPIES to be tested prior to registration is not considered workable. The intention of EACH BREEDING PARTNER being tested and certified prior to mating, would eradicate the risk of producing AFFECTED puppies PRIOR to birth. Also of note is that many puppies will be clear by parentage due to their parents ALL being CERTIFIED Clear PRIOR to mating or registration would eliminate risk. It is imperative, though that ALL BREEDING PARTNERS are individually certified PRIOR to registration of resulting progeny and PREFERABLE that BREEDING PARTNERS are tested and results are known PRIOR TO MATING. Although this method could in extenuating circumstances be unable to be conducted, due to the subjective situation of using FROZEN SEMEN (testing would be done at time of defrost or insemination), whereby an additional requirement would be that the Dam of the intended artificial insemination litter would therefore need to be certified as a CLEAR of JLPP PRIOR to insemination date.

This motion needs to be prepared using the ANKC guidelines of request for survey re LRL and represented for consideration. This motion has been moved to the NRCA SGM for discussion in General Business.

4. Cut off points for hip scores not just xrayed

Rationale: To bring inline with the NRCA Guidelines

4. This Motion is unacceptable in format and wording. This motion must be put as an ANKC LRL request as per ANKC requirements.

The correct procedure and motion had been presented to NRCA members in 2016/17 and was lost on vote due to members unable to reach a satisfactory consensus on the actual scores to be submitted to the ANKC in the request motion. In addition, the motion of HD was coupled with ED cut off scores. This was deemed to be incorrect. The HD motion requesting a survey with a view to LRL needs to be separated from a motion for ED LRL's.

2 x new motions has been prepared and will be included in the SGM agenda for Discussion in General Business.

5. The title of NRCA CHAMPION added to pedigrees

NDRC proposes the title of NRCA Champion be added to pedigrees

Rationale: Right now the Title is only valuable to NRCA members. Adding it to the pedigree will raise its value and hence raise the value of the NRCA.

5. Note: this Motion and its intention has merit, however, the ANKC will require a in depth analysis and will not accept the wording as presented here.

To “Add “ something to a pedigree” requires registration rules to be altered by way of a “proposal of title recognition”. Another consideration is that Breed survey Procedures and assessments are not currently recognized by the ANKC. To achieve a “BREED UNIQUE TITLE” would be the first time the ANKC would consider it. Many breeds and National Breed councils (NBC) have decades of tailored recognition methods. As an example the ROM- Role of merit Bull Terriers and Minature Bull Terriers. These “Titles” are not formally recognized by the ANKC and are not noted on “Pedigrees” (ANKC Certificates of Pedigree and Registration).

If you would like to prepare a Motion to pursue this through the ANKC, may I suggest you instruct the NRCA to seek input and advice from the ANKC with a view to understanding their requirements and possibility of merit to allow this to proceed.

MIXED BREEDS

Mixed breeds may be accepted provided they are a mix or ap-parent mix of Herding breeds. These must be Associate Registered Dogs

HERDING DOGS

Dogs registered with an ANKC Ltd recognized herding dog association or kindred body are able to compete in Herding Trials organized under the auspices of an ANKC Ltd Body.

Such dogs must be registered with the ANKC Ltd, and the owner and handlers be members of a Member Body.

Such dogs are to be allowed to compete without prejudice to sexual status in that they are not required to be neutered and may be bred as acceptable by the herding registry they are registered with.

INSTINCT TEST INFORMATION

Section 5. Instinct Test (Certificate only - not a Title).

- 3.5.1 The ANKC Ltd will issue an Instinct Tested Certificate to an eligible dog that has been certified by a Judge to have qualified by passing an Instinct Test.
- 3.5.2 A dog may enter an Instinct Test more than once at a single event provided each Test is judged by a different Judge. It will qualify for an Instinct Certificate provided it qualifies under one Judge.

Section 6. Instinct Test Description and Test Elements.

- 3.6.1 Judging and timing commence when the handler and dog enter the ring. Time allowed is five (5) minutes with no minimum time for completion. The dog is brought into the arena containing the livestock on a long line, approximately 2-5 metres in length. At some point while on the line, the dog must demonstrate a stop (down, sit or stand) and a call to handler before the line is dropped or removed. A dog which cannot be recalled shall not be let off line and will not qualify. The dog should show sustained interest in the stock for a greater period of time than not while in the arena. Dogs must be immediately removed from the ring if physical force is necessary to protect the stock from the dog.
- 3.6.2. A dog, which cannot be called off the stock, shall not be let off line. Dogs must be immediately removed from the ring if physical force is necessary to protect stock from the dog.
- 3.6.3. To end the Test, at the Judge's discretion, he/she will ask the Handler to call their dog off the stock. The dog is to be leashed if off the lead. Testing and timing cease once the dog is leashed. A dog which does not return to its handler or cannot be caught will not qualify.
